

Stone Creek Sidewalk/Drainage Project Update

Issue

As of today, no new proposals have been received and we have not heard from the contractors that we wished to re-negotiate a price with.

Background

This new sidewalk is intended to connect the mid EV neighborhood to the bus stops on Highway 6 and to the rec path that extends to Avon/Traer Creek and the newly constructed path on the north side of Highway 6 extending to the east and the EV Business Center. It is also needed to mitigate a drainage issue that has plagued the Met Mountain property owners at the corner of US 6 and Stone Creek Drive.

After public hearings at which the board heard from engineers, staff and area homeowners, staff was directed to construct the sidewalk subject to the Eagle County grant money of \$42,500 being available. We have received a check from them for that amount.

Discussion

Board members will recall that we had awarded the job to one particular contractor last fall, but the weather got dicey and we pulled the plug because not finishing the job before the snow came was not an option. We were also concerned that the batch plants might close prior to our need for asphalt. That contractor did not re-bid the project.


I have consulted with Eagle County and have found out that any grant funds for future projects would be part of their 2015 budget. No money is available for 2014.

Fiscal Impact

The BOG decided in November 2012 to construct the sidewalk. Eagle County has contributed \$42,500 to the project. We received a check for that amount last fall. EagleVail has made a total of \$47,500 available for the project for a total of \$90,000. An additional \$2,100 was budgeted for engineering services.

Recommendation

I still hope to have additional information for the BOG to consider at the August 21 meeting, and a recommendation for moving this project forward.

At the Board of Governors meeting of August 21 we updated the board on our plans to develop information that would allow the BOG to schedule a ballot question regarding the clubhouse relocation and other potential EagleVail improvement projects for June of 2016, if the BOG so desired. While we will develop a very detailed timeline and task list in the very near future the purpose of this memo is to provide a brief outline of the process as a follow up to our discussion last week.

This list is, at this time, a general list of the tasks and issues we will address to develop the appropriate level of information. As we develop a detailed schedule we will see that some of these tasks will run concurrently and some will need to occur in a sequential order. There will be BOG updates at most if not all of the regularly scheduled meetings between now and May of 2016 and there will be identified key decision points along the way.

Clubhouse

We will verify and update the 2011 clubhouse program with staff, with the Development, Golf and Finance committees. We will develop current cost estimates for the program and bring a staff/committee recommendation to the BOG. We will then refine the program and cost estimates based on BOG input. We would then develop conceptual architecture and site plan drawings for committee and BOG review. This work will include meetings with neighbors of the proposed clubhouse location. Clubhouse information will continue to develop and will eventually result in a Design Development plan set with a detailed cost estimate and a proposed timeframe for construction initiation and completion.

We have engaged the EagleVail golf course architect to provide options for tee box and cart path revisions required to relocate the clubhouse. These options will go through a similar staff/committee review process and will be presented to the BOG.

Existing Assets

We have initiated appraisals of existing assets including the existing clubhouse and parking lots and solicit developer input as to how these assets may be best leveraged to assist in the overall financial program. Again, we will follow a staff/committee evaluation process and present to the BOG.

Other program elements

Staff will evaluate other improvement and/or purchase elements that may be appropriate to include in a bond issue. We will evaluate those elements with the appropriate committees and present recommendations to the BOG.

Financial Plan

Staff and Ken Marchetti will work closely with the Finance Committee to develop accurate and timely financial information, options and alternatives and present recommendations to the BOG. We have spoken with Todd Snidow, a bond company representative, about our plans and asked for his guidance and participation.

Communications

Staff will develop a plan and timeline for providing accurate and useful information to the EagleVail constituency and will present this plan to the BOG for review and approval.

Election

We will include all required legal and technical tasks, steps and requirements into the overall detailed schedule.

It is our intent to provide a more detailed schedule and to update you on progress to date at the Board of Governors meeting of September 18, 2014.
